ISIS FORENSICS CHILD EXPLOITATION INVESTIGATION TOOLKIT END USER LICENCE AGREEMENT

This is a legal agreement ("Agreement") between you (the natural person or legal entity that is agreeing to be bound by this Agreement) and Isis Forensics. Isis Forensics Limited, ("Isis Forensics") an English company, licences the Software and provides technical support in all territories.

BY ACCESSING, INSTALLING OR OTHERWISE USING THE SOFTWARE, YOU ARE AGREEING TO BE BOUND BY THE TERMS OF THIS AGREEMENT. IF YOU DO NOT AGREE TO THE TERMS OF THIS AGREEMENT, DO NOT INSTALL OR USE THE SOFTWARE.

1 DEFINITIONS

- a. "Affiliate" means any legal entity that controls, is controlled by or is under common control with you or Isis Forensics (as applicable); where 'control' refers to ownership of more than fifty percent (50%) of voting securities.
- b. "Documentation" means, collectively, the operation instructions, release notes and user manuals provided by Isis Forensics for the Software, in electronic or written form.
- c. "Software" means the object code form of the Isis Forensics proprietary software product(s) licenced to you under this Agreement including any Documentation.
- d. "User" means your and your Affiliates' employees and your and your Affiliates' third party consultants and contactors who are providing services to you or your Affiliates.

2 GRANT OF LICENCE.

a. Licence. Subject to the terms of this Agreement, Isis Forensics hereby grants you a non-exclusive, non-transferable licence, without rights to sublicence, to use the Software in accordance with the Documentation. Use of the Software shall be strictly limited to the number and type of licences (whether named user, concurrent user, per device or any other approved model) purchased and paid for by you.

Under the named user model, a "named user" is a single User authorised by you to access or use the Software, regardless of whether or not the individual is using the Software at any given time. A licence is required for each User.

Under the concurrent user model, a "concurrent user" is a single User authorised by you to access or use the Software, where such User is accessing or using the Software at any given time and regardless of the number of connections used by that individual. A licence is required for each User.

Under the device model, a "device" is a device authorised by you to be used by a User to access or use of the Software, regardless of whether the device is being used at any given time. A licence is required for each such device.

Users shall use and/or access the Software solely on behalf of and for the benefit of you or your applicable Affiliate and in accordance with this Agreement. You shall be responsible for all acts and omissions committed by any Users. You may make one backup, unmodified copy of the Software solely for archival purpose.

- b. Perpetual Licence. If the Software is "Perpetual Licence Software" the Software is licenced on a perpetual basis. You acknowledge and agree that any licences purchased in addition to your initial purchase shall be considered to expand the initial licence grant and shall not constitute a separate licence to the Software.
- c. Subscription Licence. If the Software is "Subscription Licence Software" your licence is for the period of time for which you have subscribed. To extend a Subscription Licence, you must purchase and install a new licence prior to the end of the expiration of the current subscription period. Note that, unless otherwise agreed, if a new Subscription Licence is not purchased, Subscription Licence Software is not licenced for use beyond the expiration of the subscription period. Subscription Licence Software may disable itself upon the expiration of the subscription period.
 - Your Subscription Licence includes basic level support and maintenance services, as more fully detailed at [www.lsis Forensics.com/support], which expires upon expiration of the licence period. Enhanced level support may be available for separate purchase.
- d. Evaluation. If the Software is identified as "Evaluation" then, notwithstanding any contrary provision in this Agreement, you are permitted to use the Software only for internal demonstration, test or evaluation purposes in a non-production environment, and for the period specified on the software licence key (if not indicated this period will be 30 days from delivery) following which the Software may automatically disable itself. You acknowledge that Isis Forensics is not obligated to permit further use of the Software past the expiration date. NOTWITHSTANDING ANY CONTRARY PROVISION IN THIS AGREEMENT THE

EVALUATION SOFTWARE IS PROVIDED "AS-IS" WITHOUT SUPPORT OR WARRANTY OF ANY KIND, EXPRESS OR IMPLIED.

- e. Not for Resale. If the Software is identified as "Not for Resale" then, notwithstanding any contrary provision in this Agreement, you may only use the Software if you are a current Isis Forensics authorised distributor or program partner/participant and then only for demonstration purposes in support of your customers. This licence will terminate automatically upon you ceasing to be an Isis Forensics authorised distributor or program partner/participant. Not for Resale Software may not be used for customer training unless otherwise agreed by Isis Forensics. This licence may be terminated by Isis Forensics at any time, with or without cause. NOTWITHSTANDING ANY CONTRARY PROVISION IN THIS AGREEMENT, NOT FOR RESALE SOFTWARE IS PROVIDED "AS-IS" WITHOUT SUPPORT OR WARRANTY OF ANY KIND, EXPRESS OR IMPLIED.
- f. Open Source Software. You acknowledge and agree that the Software may be provided with certain open source software (as defined by the Open Source Initiative) or freeware software (collectively, "Open Source Software"), as referenced in the Documentation, for use in combination with the Software. Such Open Source Software is free and distributed to you solely under the terms set forth in the respective Open Source Software licence agreements (which are referenced in the Documentation and/or the Isis Forensics website) and you acknowledge and agree that this Agreement in no way supplements or detracts from any term or condition therein.
- 3 **SUPPORT AND MAINTENANCE SERVICES.** Except as specified for Subscription Licence Software, Isis Forensics does not provide any technical support or maintenance services for the Software under this Agreement and you have no rights to any updates, upgrades, enhancements or other modifications to the Software (collectively "Updates") unless you purchase Isis Forensics support and maintenance services. All support and maintenance services provided for Perpetual Licences and Subscription Licences are subject to Isis Forensics's then-current terms and conditions as apply to support and maintenance services as displayed at www.isis-forensics.com/legals]. If you purchase support and maintenance services for the Software, you are required to purchase and maintain such services at the same level for all licences of the Software. Any generally available Updates provided to you pursuant to the maintenance services shall be considered Software under the terms of this Agreement.
- 4 LICENCE RESTRICTIONS. The Software is licenced, not sold. You may not use the Software for any purpose beyond the scope of the licences granted in this Agreement, all other rights are reserved by Isis Forensics or its suppliers. Without limiting the generality of the foregoing and except as expressly permitted in this Agreement, you will not (and will not permit any User or third party to): (i) authorise or permit use of the Software by persons other than Users; (ii) assign, sublicence, distribute, sell, lease, rent, novate or otherwise transfer or convey the Software or Documentation to any third party without Isis Forensics' prior written consent or disclose the software licence key to the Software to any third party; (iii) pledge as security or otherwise encumber the rights granted under this Agreement; (iv) modify, adapt or create any derivative works of the Software (or any component thereof); (v) decompile, disassemble, reverse engineer or otherwise attempt to obtain or perceive the source code from which any component of the Software except and only to the extent: (a) that applicable law expressly permits such actions despite this limitation; or (b) required to debug changes to any third party LGPL-libraries linked to by the Software; (vi) use the Software as a service bureau, ASP or SaaS offering for third parties; (vii) circumvent or attempt to circumvent any technical restrictions in the Software; or (viii) remove, alter or obscure any proprietary notices or legends from the Software or any copies thereof.

You hereby agree that, to the extent that any applicable mandatory laws give you the right to perform any of the aforementioned activities without the consent of Isis Forensics to gain certain information about the Software, before you exercise any such rights, you shall first request such information from Isis Forensics in writing detailing the purpose for which you need the information. Only if and after Isis Forensics, at its sole discretion, denies your request, shall you exercise your statutory rights.

- TITLE. Isis Forensics and its licensors (if any) retain all rights, title and interest, including all patent, copyright, trade secret, trademark, moral rights and other intellectual property rights, in and to the Software and Isis Forensics expressly reserves all rights not expressly granted under this Agreement.
- 6 **INFRINGEMENT INDEMNIFICATION**. Isis Forensics undertakes to indemnify and defend, or at its option, settle any claim, suit or proceeding brought against you based on an allegation that the Software infringes upon any patent or copyright of any third party ("Infringement Claim") and Isis Forensics shall pay all third party costs and damages awarded in judgment of the Claim or agreed to in settlement of the Claim between Isis Forensics and the third party, provided that that you promptly notify Isis Forensics in writing of an Infringement Claim such that Isis Forensics is not prejudiced by any delay in such notification and do nothing which may prejudice Isis Forensics' defence of such Infringement Claim. Isis Forensics will have sole control over the defence or settlement of any Infringement Claim and you will provide reasonable assistance at Isis Forensics' expense. If any Infringement Claim is made or appears possible, Isis Forensics may at its sole expense and

option: (i) procure for you the right to continue to use the alleged infringing Software; (ii) replace or modify the Software to make it non-infringing; or (iii) if neither (i) nor (ii) are reasonably achievable, accept return of the Software and provide you with a refund of the licence fees paid by you for the affected Software based on a straight line depreciated value over 5 years. Isis Forensics assumes no liability for any Infringement Claim or allegations of infringement based on: (i) the combination, operation, or use of the Software with products, services, hardware, data or other materials not furnished by Isis Forensics, if such Infringement Claim would have been avoided by the use of the Software alone; (ii) modifications to the Software by you or at your direction; (iii) your use of any Software after notice that you should cease use of the Software due to an Infringement Claim, where Isis Forensics had provided you with a subsequent no-infringing release of the Software; or (iv) use of the Software otherwise than in accordance with the Documentation and any applicable laws and regulations. THE FOREGOING STATES YOUR EXCLUSIVE REMEDY WITH RESPECT TO ANY INFRINGEMENT CLAIM.

LIMITED WARRANTY AND DISCLAIMER. Isis Forensics warrants that for a period of thirty (30) days from the date of delivery of the licence key for the Software to you, the Software will perform substantially in accordance with the Documentation. Isis Forensics and its authorised resellers and distributors' entire liability and your exclusive remedy under this warranty (which is subject to you deleting all copies of the Software within your possession and control and certifying in writing to Isis Forensics or an authorised reseller that you have done so) will be, at the sole option of Isis Forensics and subject to applicable law, to replace the Software or to refund the licence fees paid and terminate this Agreement. This limited warranty will not apply unless: (i) the Software has been properly installed and used at all times in accordance with the Documentation; (ii) no modification, deletion or addition has been made other than by Isis Forensics and (iii) Isis Forensics receives written notice of the non-conformity within the warranty period.

- 9 **TERMINATION.** You may terminate this Agreement without refund at any time by removing the Software from your computers and destroying all copies and providing written notice to Isis Forensics. Isis Forensics may terminate this Agreement in the event that you breach this Agreement and (if such breach is capable of remedy) you fail to remedy such breach within 30 days from Isis Forensics's notice to you. Upon termination of this Agreement, the licence granted herein will terminate and you must immediately remove and destroy all copies of the Software, including all back-up copies. Any obligations to pay fees incurred prior to termination shall survive termination for any reason.
- 10 **AUDIT.** During the term of this Agreement and for two (2) years after termination of the Agreement or support and maintenance services for the applicable Software, you shall maintain accurate and complete records regarding your use of the Software and you shall permit Isis Forensics (or persons authorised by Isis Forensics)

to inspect such records and your computer equipment in order to verify that your use of the Software is in compliance with this Agreement and that you have paid the applicable licence fees and support services fees for the Software. Isis Forensics may not conduct an audit more than once per calendar year and such audits shall take place during normal business hours and on reasonable prior notice. Without prejudice to any other rights and remedies, where such audit reveals any underpayment, you shall immediately pay such underpayment to Isis Forensics and where any underpayment is more than five percent (5%) of the amounts payable by you for the audited period you shall promptly reimburse Isis Forensics for the reasonable costs of the audit.

11 GENERAL

- a. Export Restriction. You will not, directly or indirectly export or re-export or knowingly permit the export or re-export of any Software in breach of any applicable export and import control laws and regulations including regulations of the United States Bureau of Industry and Security and other applicable agencies. This Agreement will be governed by the laws of the England and Wales without regard to conflict of laws principles and in any dispute arising out of or in connection with this Agreement you consent to the jurisdiction of the English courts. You agree that, to the fullest extent permitted, the provisions of the Uniform Computer Information Transactions Act and/or any federal or state statutory adoptions or equivalent in effect at any time (whether before or after the date of this Agreement) shall not apply to this Agreement and the United Nations Convention for the International Sale of Goods shall not apply to this Agreement.
- e. Severance. If any provision of this Agreement is held to be unenforceable, void or invalid under applicable law, such provision shall be deemed omitted and the remaining provisions will remain in full force.
- f. Entire Agreement; English Language Agreement Controls. This Agreement represents the complete and exclusive statement of the agreement between Isis Forensics and you with respect to the Software and supersedes all prior or contemporaneous oral or written communications and arrangements concerning the subject matter contained herein. In the event of any inconsistency between this Agreement in English language and any translation of it into another language, the English language Agreement shall control.
- g. No Waiver. No failure or delay to exercise any right or remedy provided under this Agreement or by law shall constitute a waiver of that or any other rights or remedy, nor shall it preclude or restrict the further exercise of that or any other right or remedy. No single or partial exercise of such right shall preclude or restrict the further exercise of that or any other right or remedy.
